

**Disclosure No. 113/CORP/9981/X/19 dated 2 October 2019**

On 2 October 2019, PT United Tractors Tbk (“Company”) disclosed the information to the Financial Services Authority related to the Amendment to Shareholder Loan Agreement between the Company and PT United Tractors Pandu Engineering (“UTE”), as the compliance with Rule No. IX.E.1, Attachment to the Chairman of Capital Market and Financial Institution Supervisory Board Decree No. KEP-412/BL/2009 dated 25 November 2009 on Affiliated Party Transaction and Conflict of Interest (“**Rule IX.E.1**”).

- Referring to Letter No. 118/CORP/9981/IX/18 dated 28 September 2018 (“**Disclosure 28 September 2018**”), the Company had disclosed to the Financial Services Authority the information regarding Shareholder Loan Agreement dated 26 September 2018 between the Company and UTE, a subsidiary of the Company (“**Agreement**”).
- On 30 September 2019, the Company and UTE entered into the Amendment to the Agreement amending certain terms under the Agreement, as follows:

Fund Availability Period : 26 September 2018 to 26 September 2019.

To become :

Fund Availability Period : 26 September 2018 to 26 September 2020.

Other than above, the information which had been disclosed under the Disclosure 28 September 2018 remain valid.
