To all honourable shareholders of the Company, please be informed that the Company intends to hold an **Annual General Meeting of Shareholders 2020** (the "**Meeting**"), which will be held on:

Pursuant to paragraphs 1 and 3 of Article 13 of Regulation of Financial Services Authority or *Otoritas Jasa Keuangan* No. 32/POJK.04/2014 dated 8 December 2014 regarding the Plan and Implementation of General Meeting of Shareholders of a Public Company ("POJK 32/2014") which has been amended by Regulation of Financial Services Authority or *Otoritas Jasa Keuangan* No. 10/POJK.04/2017 regarding the amendment of POJK 32/2014, the invitation of the Meeting will be announced on 17 March 2020, in at least 1 (one) daily Indonesian language newspaper widely circulated within the territory of the Republic of Indonesia, the Indonesian Stock Exchange's website; and the Company's website, in Indonesian and English language.

Pursuant to paragraph 10 of Article 9 of the Articles of Association of the Company in conjunction with paragraph 2 of Article 19 of POJK 32/2014, shareholders who are entitled to attend the Meeting are those whose names are registered in the Shareholders Registry of the Company 1 (one) business day before the meeting invitation date, being **16 March 2020** until 4.00 PM WIT.

Pursuant to paragraph 5 of Article 21 of the Articles of Association of the Company in conjunction with Article 12 of POJK 32/2014, any proposals to the agenda of the Meeting from shareholders of the Company shall be included as the agenda of the Meeting, if the following requirements are fulfilled:

- It is proposed in writing to the Board of Directors of the Company by one or more shareholders, who jointly represent at least 5% (five percent) of the total shares with valid voting rights, issued by the Company;
- The proposal is received by the Board of Directors of the Company at the latest 7 (seven) days prior to the date of the Meeting invitation, being 10 March 2020 at the latest at 4.00 PM WIT;
- 3. It should (a) be made in good faith, (b) consider the interests of the Company, (c) include the reason and material for the agenda item, and (d) not contradict with the Articles of Association of the Company and/or the prevailing laws and regulations.
